### 3. Composition/information on ingredients

### 4. First aid measures

### Methods for cleaning up

## 7. Handling and storage

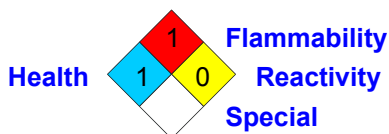
